

## UNFINISHED BUSINESS:

New flag lights have been installed by Greg Fink at cost of \$1800; lights are recessed at ground level and have a protective covering to limit vandalism.

New fence, phase I, completed.

Mulch is scheduled to be delivered to the park for the playground/swing/tot lot areas on 5/25. GRRB members and volunteers will assist Ron M. with spreading/raking of mulch. Cost will be \$2,130.

Summer playground assistants: Adam Bocek, Kate Jones, Krystal, Steenwyk, Steven Lutz, Breanne Chandler will be submitted to borough council for hire approval. Updated posters (courtesy of Roger Butz) will be posted at various locations in the community.

Flemmens received an email from Ann Merrick, 5/13, with a copy of the letter sent to each assistant related to the required background checks. Ann completed the PA State Police checks for all the assistants. See attachment for sample letter.

## **NEW BUSINESS:**

Hufnagel and Flemmens met with Sandy Fair at the memorial circle to review the placement of the Sesquicentennial brick walkway. The proposed walkway would start at the street and curve to the tennis court side of the memorial, around the memorial on that side and if enough bricks would then curve toward the pavilion. Good reported that Greg Fink might assist with any grading required to place the pathway; Fair to contact him directly. R. McCullough will be asked to remove the 'burning bushes' from the circle since the bushes are overgrown and obstruct the view. No projected date to begin the pathway at this time but the bricks will need to be removed from the BR storage are prior to the beginning of the summer playground program.

The Board approved reimbursing Jay Good for materials required to repair a damaged table/bench-Flemmens motioned, Hufnagel 2<sup>nd</sup>.

Sue Good to check the volleyball nets for tears, previous nets were purchased at Grove's Sporting Goods. Will also check 'loose' tennis net - may require adjusting with crank (located in BR storage area).

Doug Young to place GRRB meetings on web site calendar, will provide Flemmens with information to place minutes on GR web site.

Glen Rock Borough is now requiring three background checks for all employees over the age of 18, who are employed to work with children in the Summer Park Program. Glen Rock Borough has already completed the Pennsylvania State Police Criminal Record Check. You are required to complete the Dept of Public Welfare check and the FBI Clearance Background check. I have enclosed a copy of the Pennsylvania Child Abuse History Clearance for you to fill out and submit to the Dept of Public Welfare. Please see enclosed guidelines for completing the FBI Clearance Background check. You will be reimbursed \$10.00 for the Dept of Public Welfare check and \$36.00 for the FBI Clearance when you submit your receipt for these fees.
